※ Sales Volume Calculation Method:

- Personal AGM Organization Volume X 100%
- First-generation AGM Organization Volume X 60%
- Second-generation AGM Organization Volume X 40%
- Third-generation AGM Organization Volume X 20%

※ Volume Requirements:

1. The calculation is based on the qualifying first generation AGMs (qualifying first generation AGM refers to downline AGM with at least S\$13,850 Group Volume in one single country), AGM's own Organization Volume must qualify for the following volume:

- 0, than Minimum Annual AGM Group Qualification Volume is S\$1,038,748
- 1, than Minimum Annual AGM Group Qualification Volume is S\$646,332
- 2, than Minimum Annual AGM Group Qualification Volume is S\$553,999
- 3, than Minimum Annual AGM Group Qualification Volume is S\$461,666
- 4, than Minimum Annual AGM Group Qualification Volume is S\$300,083
- 5, than Minimum Annual AGM Group Qualification Volume is S\$138,500
- 6, than Minimum Annual AGM Group Qualification Volume is S\$46,167

2. AGM has to achieve at least S\$13,850 Group Volume in one single country.

3) AGM Sales Awards

- * Personal AGM Organization Volume is S\$761,749.
- * Not eligible for the above AGM Sales Award, if awardees qualified for both NET and AGM Sales Award in the same time.
