

Ground trip and accommodation will be arranged and fully paid by the company. Participants will be required to purchase their own flight tickets, visa and personal travel insurance. The Company will subsidize the air tickets based on the following criteria:

Terms and Conditions:

1. The entitlement for this trip is non-transferable. The trip shall be deemed as forfeited if achievers are unable to attend.
2. Couples who are registered under a Joint-Distributorship account will only be entitled to one placement for the trip, the accompanying spouse can join at a preferential rate of S\$3,500.
3. The spouse of an invited AGM, holding an Individual account with the AGM pin title, is eligible to join at a preferential rate of S\$4,500.
4. Achievers who are interested in joining the trip are required to submit their [registration form](#) to the Customer Service team by 25 January 2025 via email or by hand.
5. Participants are required to apply for the visa before departure date at their own cost, if applicable.
6. Travel insurance is not included in the travel package. Participants are strongly encouraged to purchase their own personal travel insurance. The Company will not be held responsible for any illness or disease contracted by participants during the trip.
7. The Company will have the discretion to decide on all necessary travel arrangements such as departure time, allocation of accommodation, meals and itinerary.
8. Accommodation is based on twin-sharing. Request for single room occupancy must be made upon registration, chargeable at S\$350 per night. Once the request is approved, no refund will be allowed.

9. Special meals and dietary requirements are subject to availability by the airlines/hotels. Do note that there are no halal meals on tour.
 10. Meal selections during the trip cannot be changed unless there are valid medical reasons.
 11. To ensure safety of everyone, participants are advised to comply with the instructions specified by the company at all time. Nefful International will not be responsible for any loss of personal belongings or accidents that may occur during the trip.
 12. Requests for travel period extensions are at the individual's discretion, and the company will not be responsible for any extended trips.
 13. All cost, inclusive of transportation and accommodation will not be allowed for cash refund or exchange for other transportation and accommodation reimbursement even if it is not fully expended.
 14. Withdrawal or changes will not be allowed once registration is submitted. A penalty fee of S\$5,000 will be charged for no-show.
 15. In the event that a participant fails to attend on time or leaves the group without authorization due to personal reasons, the company will not issue any refunds and reserves the right to charge a penalty fee of S\$2,000 to cover the difference in event costs.
 16. Achievers of Decamillion Master Performance Award – Noir Brilliance & above may select their own flight timing instead of the recommended flight timing by the company, however, if the air fare is higher than the recommended flight, participants will be required to top-up the price difference. Participants are also required to inform the company on the preferred flight schedule before 25 January 2025.
